The general description of the nature of the improvements in the agreement includes, but not limited to: (1) Wind Turbines; (2) Towers; (3) Foundations, roadways, buildings and offices; (3) Meteorological equipment (anemometer towers and SODAR); (4) Computer equipment; (5) Furniture; (6) Company vehicles; (7) Electrical transmission cables and towers, and electrical substations; and (8) Associated equipment for generating, storing, controlling, and transmitting electricity.
- iv. The estimated cost of the improvements being contemplated by Lazbuddie Wind Energy LLC is between \$175,000,000.00 - \$275,000,000.00.
